(D) Be in good enough physical condition to hunt in areas and game involved as described by Outfitter.

(E) Purchase all licenses, permits or stamps required for each hunt.

(F) Refrain from consuming any mind altering substances during the hunting day.

(G) Assume full responsibility for all animals taken whether willfully, accidentally, or illegally.

(H) Agree that a wounded animal will be considered a kill and his hunt for that species will be considered complete. All efforts will be made to recover wounded animal. (**Diamond T Trophy Hunts, LLC** discretion may apply.)

(I) I understand that this hunt is not a guaranteed kill hunt.

(J) I also give **Diamond T Trophy Hunts, LLC** permission to use my name, phone number, pictures for advertisements and references.
